*Escherichia coli* strain P68 is a whole-genome sequenced bacterium that was isolated from cattle hides. This strain is non-toxigenic and is recommended by the USDA as a surrogate indicator organism to measure changes in microbial counts. **Strain designation:** P68 **Type strain:** No

#### Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.

5. Incubate the tubes and plate at 37°C for 24 hours.

The depositor states that no cytotoxicity was observed with African green monkey kidney (Vero) cells. The lack of virulence factor genes has been confirmed by the *E. coli* Reference Center of Pennsylvania State University.
