- 2. Transfer thawed cells into a single tube of #18 broth (5 to 6 ml).

3. Use several drops of the suspension to inoculate additional tubes of broth, agar slants, and/or plate.

4. Incubate the tubes and plate at 37°C for 24-48 hours.
