For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

1. This organism is shipped frozen on dry ice. Just prior to use, thaw the vial in a 37°C water bath.
2. Transfer the entire contents of the vial to a tube of #18 broth (5 to 6 mL).
3. Use several drops of the cell suspension to inoculate a #18 agar slant and/or plate. Additional #18 broth tubes may be inoculated by transferring 0.5 mL of

the primary tube to each addition broth tube.

4. Incubate the tubes and plate at 37°C for 24 hours

Notes

Colonies on #18 agar are smooth, convex, circular, translucent, cream and entire.

NOTE: Vial should be stored at -80°C or lower until ready to be used. Storage in vapor phase liquid nitrogen is preferred for long term storage.
