Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## **Handling Procedures**

1. Just prior to inoculation place the frozen vial at room temperature to thaw.
2. Transfer the entire contents of the vial to a tube of #18 broth (5 to 6 ml).

3. Use several drops of the cell suspension to inoculate a #18 agar slant and/or plate. Additional #18 broth tubes may be inoculated by transferring 0.5 ml of the primary tube to each additional broth tube.

4. Incubate the tubes and plate at 37°C for 24 hours.
