Handling Procedures

- 1. Open vial according to enclosed instructions.
- Using a single tube of #3 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.

- 4. Use several drops of the suspension to inoculate a #3 agar slant and/or plate.
- 5. Incubate the tubes and plate at 37°C for 24 hours.

Notes

Colonies on #3 plates are round, smooth, entire, circular, translucent and glistening. This strain was confirmed by PCR to carry the *eae* and *stx*2 genes (*stx*1-, *stx*2+, *eae*+). Additional information on this culture is available on the ATCC[®] web site at www.atcc.org
