## Growth Conditions

**Medium:**

ATCC Medium 44: Brain Heart Infusion Agar/Broth

ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

**Temperature:** 37°C**Atmosphere:** 95% Air, 5% CO<sub>2</sub>

## Handling Procedures

1. Open vial.
2. Using a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.

4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.
  5. Incubate the tubes and plate at 37°C for 24 hours in atmosphere of 5% CO<sub>2</sub>.  
Loosen the screw caps during the incubation.
