Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

1. Immediately prior to working with the culture place the frozen vial at room temperature to thaw.

2. Add substrates to the medium. If the medium is more than a week old, exchange the head space for 100% $N_{\rm 2}.$

3. Using a syringe, aseptically transfer the entire contents of the vial into a single tube (8 to 10 ml) of #2727 broth. Mix well.

4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate. Additional tubes of #2727 broth can be inoculated by transferring 0.5 ml of the

original broth.

5. Incubate the tubes and plate at 30°C for 48 to 72 hours.

Notes

This culture must be grown under anaerobic conditions to utilize perchlorate. This culture will also grow aerobically on TSA. Colonies on aerobic #18 plates are rounded, entire, and clear. There are two colony sizes.
