## Handling Procedures

1. Open the vial according to enclosed instructions.
2. From a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1

- mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
  4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.
  5. Incubate all tubes and plate at 37°C for 24 hours.

## **Notes**

Within 24 hours colonies on #18 agar may appear entire, smooth, glistening, and low convex.

This strain was confirmed by PCR to carry the *eae*, *stx1*, and *stx2* genes (*stx1+*, *stx2+*, *eae+*).
