Handling Procedures

- 1. Open the vial according to enclosed instructions.
- 2. From a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1

mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.

- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.
- 5. Incubate all tubes and plate at 37°C for 24 hours.

Notes

Within 24 hours colonies on #18 agar may appear entire, smooth, glistening, and low convex.

This strain was confirmed by PCR to carry the eae, stx1, and stx2 genes (stx1+, stx2+, eae+).
