Neisseria gonorrhoeae strain SK-92-679 was isolated in 1992 from the blood of a woman diagnosed with disseminated gonococcal infection (DGI) at a hospital in Seattle, Washington. This strain is tetracycline-resistant and has applications in sexually transmitted disease research. **Strain designation:** SK-92-679 **Type strain:** No

For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

#### **Growth Conditions**

Medium: ATCC Medium 814: GC Agar/Broth Medium Temperature: 37°C Atmosphere: 95% Air, 5% CO<sub>2</sub>

#### Handling Procedures

- 1. Open vial according to enclosed instructions.
- Using a single tube of #814 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.

- 4. Use several drops of the suspension to inoculate a #814 agar slant and/or plate.
- 5. Incubate the tubes and plate at 37°C for 24-48 hours in an atmosphere of 5 % CO<sub>2</sub>. Loosen the screw caps during the incubation period.

#### Notes

Brain Heart Infusion (BD 237500) can be used to rehydrate vial contents if #814 broth is not available, but it will not support growth as well as the GC broth. For testing of Tetracycline, the recommended media to use is Remel GC Base with 1% GCHI (Ref# R01460); incubate at 35°C for 20-24 hrs.
