For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

#### **Growth Conditions**

**Medium:** 

ATCC Medium 2745: Half Tryptic Soy Broth Media for Sphaerochaeta spp.

Temperature: 26°C

Atmosphere: 80% N<sub>2</sub>, 20% CO<sub>2</sub>; 100% N<sub>2</sub>

### Handling Procedures

- 1. Immediately prior to working with the culture, place the frozen vial at room temperature to thaw.
- 2. If the medium is more than a week old, exchange the head space for fresh  $80\%\ N_2$   $20\%\ CO_2$ .
- 3. Using a syringe, aseptically transfer the entire contents of the vial into a single tube (8 to 10 ml) of #2745 broth. Mix well.

- 4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate. Additional tubes of #2745 broth can be inoculated by transferring 0.5 ml of the original broth.
- 5. Incubate the tubes and plate at 26°C for 5 to 7 days.

#### Notes

This culture must be grown under anaerobic conditions. No aerobic growth was detected.
