Salmonella enterica subsp. enterica serovar Typhimurium strain G11013 was isolated from a human in the United States. This bacterium is a representative strain of multidrug-resistant Salmonella enterica subsp. enterica serovar Typhimurium DT104. It is resistant to Ampicillin, Chloramphenicol, Spectinomycin, Streptomycin, Sulfonamides, and Tetracycline.

### **Handling Procedures**

- 1. Open vial.
- 2. Using a single tube of #3 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a second tube of broth, a slant, and/or plate.
- 5. Incubate all tubes and plate at 37°C for 24 hours.
