## Description

*Anaerostipes hadrus* strain 5\_1\_63FAA is an anaerobic bacterium that was isolated from a human subject in Canada as part of the Human Microbiome Project.

Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Growth Conditions

**Medium:**

ATCC Medium 1827: BHI with heat-inactivated fetal bovine serum and glucose

ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

**Temperature:** 37°C

**Atmosphere:** Anaerobic

---

## Handling Procedures

1. Open vial according to enclosed instructions.
2. Under anaerobic conditions, withdraw 0.5 mL of #1827 broth from a single test tube (5-6 mL) and rehydrate the entire vial contents.
3. Aseptically transfer this aliquot back into the broth tube. Mix well. Additional

tubes may be inoculated with 0.5 mL each from the suspension. Streak a #260 plate to check for purity.

4. Incubate tubes under an anaerobic atmosphere at 37°C for 1 week. Incubate blood plate aerobically for aerobic contamination check.

**ANAEROBIC CONDITIONS:**

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber, or
- Placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber,
- Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

---

**Notes**

After 1 week incubation, growth should be visible microscopically as nonmotile rods. No colonies are formed on agar. No growth should occur on plates incubated aerobically.

Always use freshly prepared pre-reduced media or pre-reduced media that has been previously prepared but stored under anaerobic conditions. Resazurin in the media is a color indicator for anaerobic conditions. Observance of pink color in medium before use or during incubation shows anaerobic conditions have not been met and oxidation has occurred. Medium should be discarded.
