*Escherichia coli* strain J53 pMG223 is a drug-resistant bacterium that was derived from the clinical isolate *Klebsiella pneumoniae* (ATCC 14714). It produces extended spectrum beta-lactamase (ESBL) TEM-10 and has applications for antimicrobial resistance research and drug development.

Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

### **Handling Procedures**

1. Open vial.
2. Using a single tube of #2290 broth (5 to 6 mL), withdraw approximately 0.5 to

- 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
  3. Aseptically transfer this aliquot back into the broth tube. Mix well.
  4. Use several drops of the suspension to inoculate a #2290 agar slant and/or plate.
  5. Incubate the tubes and plate at 37°C for 24 hours.
