### Description

Escherichia coli strain J53 pMG223 is a drug-resistant bacterium that was derived from the clinical isolate Klebsiella pneumoniae (ATCC 14714). It produces extended spectrum beta-lactamase (ESBL) TEM-10 and has applications for antimicrobial resistance research and drug development.

### Handling Procedures

- 1. Open vial.
- 2. Using a single tube of #2290 broth (5 to 6 mL), withdraw approximately 0.5 to

- 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #2290 agar slant and/or plate.
- 5. Incubate the tubes and plate at 37°C for 24 hours.
