Handling Procedures

- 1. Open vial according to enclosed instructions.
- Using a single tube of #2290 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #2290 agar slant and/or plate.

5. Incubate the tubes and plate at 37°C for 24 hours.

Notes

Colonies on #2290 plates are cream, circular, entire, low convex, translucent, and smooth.
