*Pseudomonas aeruginosa* strain PG02332 was collected from a sputum sample of a cystic fibrosis patient during a Phase III clinical trial that tested the effectiveness of aerosolized Tobi (Tobramycin). This strain is propagated aerobically in trypticase soy medium.

Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

2. Aseptically transfer the entire contents to a 5-6 mL tube of #18 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary

- broth tube to these secondary tubes.
3. Use several drops of the primary broth tube to inoculate a #18 plate and/or agar slant.
  4. Incubate at 37°C for 24 hours.
