

# Pseudomonas aeruginosa (Schroeter) Migula

*Pseudomonas aeruginosa* strain PGO2364 is a bacterial strain that was isolated from the sputum sample of a cystic fibrosis patient during a Phase III clinical trial that tested the effectiveness of aerosolized Tobi (Tobramycin). The presence of a phage has been observed in this strain.

For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

### Handling Procedures

- 1. Open thawed vial.
- 2. Aseptically transfer the entire contents to a 5-6 mL tube of #18 broth.

  Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.

- 3. Use several drops of the primary broth tube to inoculate a #18 plate and/or #18 agar slant.
- 4. Incubate at 37°C for 24 hours.

This strain of *Pseudomonas aeruginosa* was isolated from a clinical drug trial for cystic fibrosis patients.
