*Pseudomonas aeruginosa* strain PGO2401 is a drug-resistant bacterium that was collected from a sputum sample of a cystic fibrosis patient during a Phase III clinical trial that tested the effectiveness of aerosolized Tobi (Tobramycin). This strain is whole-genome sequenced and has applications in antimicrobial resistance research and drug development. **Strain designation:** PGO2401

Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

#### Handling Procedures

- 1. Just prior to inoculation place the frozen vial at room temperature to thaw.
- 2. Transfer the entire contents of the vial to a tube of #18 broth (5 to 6 mL).

- 3. Use several drops of the cell suspension to inoculate a #18 agar slant and/or plate. Additional #18 broth tubes may be inoculated by transferring 0.5 mL of the primary tube to each addition broth tube.
- 4. Incubate the tubes and plate at 37°C for 24 hours.

#### Notes

The cells are highly motile rods that stain Gram-negative. This strain of *Pseudomonas aeruginosa* is a multidrug-resistant strain that was isolated from a clinical drug trial for cystic fibrosis patients.
