## Handling Procedures

1. Open thawed vial according to enclosed instructions or visit [www.atcc.org](http://www.atcc.org) for instructions.
2. Aseptically transfer the entire contents to a 5-6 mL tube of #2872 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
3. Use several drops of the primary broth tube to inoculate a #2872 plate and/or

#2872 agar slant.

4. Incubate at 42°C with indirect light for 3 weeks.

## Notes

This organism requires indirect light for growth.

Growth has a bright green pigment.

This item grow better on agar than in broth. Castenholtz agar prevents the overgrowth of the other organisms in the xenic culture.

The co-cultures consist primarily of *Selenomonas*, but *M. ferruginea* is the only cyanobacterium present.
