Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

#### Handling Procedures

- 1. Open vial.
- 2. Using a single tube of #18 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.

5. Incubate the tubes and plate at 30°C for 24 hours.

#### Notes

Colony morphology on #18 agar is tiny, circular, glistening, translucent, low convex, smooth, and entire. In broth culture, a chalky, flaky residue is formed on top of the broth culture, and it is highly turbid. Cells are highly motile rods that are small and stain gram negative.
