## Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #3 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.

4. Use several drops of the suspension to inoculate additional #3 broth tubes, an agar slant, and/or plate.
  5. Incubate the tubes and plate at 37°C for 24 hours.

## Notes

Colonies on #3 agar are circular, entire, low convex, transparent, and glistening.

This strain was confirmed by PCR to carry the *eae* and *stx1* genes (*stx1+*, *stx2-*, *eae+*).
