Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.



- 4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.
- 5. Incubate the tubes and plate at 37°C for 24 hours.

Notes

Colonies of #18 plates are circular, entire, smooth, low convex, and cream colored. This strain was confirmed by PCR to carry the eae and stx1 genes (stx1+, stx2-, eae+). Additional information on this culture is available on the ATCC $^{\circ}$ web site at www.atcc.org.
