ATCC highly recommends that appropriate personal protective equipment is always used when handling vials. For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

#### Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.
- 5. Incubate the tubes and plate at 37°C for 24 hours.

#### Notes

Colonies on #18 plates are circular, entire, smooth, low convex, and cream colored. This organism displays multiple colony types on MacConkey agar.

The primary colony type is positive for lactose fermentation, while the secondary is negative.

Biochemical characterization of the individual colony types by Vitek, as well as genotypic characterization by riboprinting and PCR have determined they are the same.

This strain was confirmed by PCR to carry the eae and stx2 genes (stx1-, stx2+, eae+).
