Escherichia coli strain 2001-3357 is a whole-genome sequenced EHEC (STEC with LEE/eae) strain confirmed by PCR to carry the *eae*, *stx1* and *stx2* genes (*stx1+*, *stx2+*, *eae+*). Serotype is O111.

Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #3 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.

4. Use several drops of the suspension to inoculate a #3 agar slant and/or plate.
 5. Incubate the tubes and plate at 37°C for 24 hours.

Notes

Colony morphology on #3 agar is translucent, circular, glistening, raised, smooth, and entire. Cells are gram negative motile rods.

This strain was confirmed by PCR to carry the *stx1*, *stx2*, and *eae* genes (*stx1+*, *stx2+*, *eae+*).
