## Handling Procedures

1. Open vial according to enclosed instructions.
  2. Using a single tube of modified #1723 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
  3. Aseptically transfer this aliquot back into the broth tube. Mix well.
  4. Use several drops of the suspension to inoculate additional broths.
  5. Incubate the tubes at 70°C for 72 to 96 hours. Growth is enhanced with gentle shaking.

## Notes

When making media for this organism, the glassware needs to be new, without treatment with any kind of detergent. Detergents will inhibit growth and possibly kill the organism. This organism does not have a long shelf life; it will die if it sits at room temperature for prolonged periods, as well as incubating for longer than the specified period of time.

This organism prefers broth propagation over agar; there will be little to no colony formation. The cells are irregularly shaped cocci that are non-motile.
