This whole-genome sequenced strain of *Enterococcus faecium* was isolated from human feces. It is multidrug resistant and was confirmed by PCR to harbor the *vanA* gene. It has applications in antimicrobial resistance research and drug development.

ATCC highly recommends that appropriate personal protective equipment is always used when handling vials. For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Medium:

ATCC Medium 18: Trypticase Soy Agar/Broth

ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

Temperature: 37°C

Atmosphere: Aerobic (5% CO₂ will enhance growth)

Handling Procedures

1. Open vial according to enclosed instructions or visit www.atcc.org for instructions.
2. Rehydrate the entire pellet with approximately 0.5 mL of #18 broth. Aseptically

transfer the entire contents to a 5-6 mL tube of #18 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.

3. Use several drops of the primary broth tube to inoculate a #260 plate and/or #260 agar slant.
4. Incubate at 37°C for 24 hours.

Confirmed by PCR to carry the *vanA* vancomycin resistance gene.
