Description

This whole-genome sequenced strain of Enterococcus faecium was isolated from human feces. It is multidrug resistant and was confirmed by PCR to harbor the vanA gene. It has applications in antimicrobial resistance research and drug development.

Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

- 1. Open vial according to enclosed instructions or visit www.atcc.org for instructions.
- 2. Rehydrate the entire pellet with approximately 0.5 mL of #18 broth. Aseptically

transfer the entire contents to a 5-6 mL tube of #18 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.

- 3. Use several drops of the primary broth tube to inoculate a #260 plate and/or #260 agar slant.
- 4. Incubate at 37°C for 24 hours.

Notes

Confirmed by PCR to carry the *vanA* vancomycin resistance gene.
