Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #18 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube and mix well. Transfer 0.5

ml to a second broth tube and mix well. Transfers to solid media can be made from the second tube.

4. Incubate broth tubes, slants and plates at 30°C for 24 hours.

Notes

Colonies are creamy, circular, slightly raised, entire, and glistening.
