Klebsiella pneumoniae strain 1101160 is a whole-genome sequenced bacterium that was isolated from a clinical specimen. This is a KPC reference strain that is resistant to ertapenem and imipenem. The strain has applications in antimicrobial resistance research, drug development, infectious disease research, and respiratory disease research.

Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

1. Open vial.
2. Using a single tube of #3 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0

- mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a #3 agar slant and/or plate.
 5. Incubate the tubes and plate at 37°C for 24 hours.
