### Description

Enterococcus faecalis is a whole-genome sequenced bacterium that was isolated from a clinical specimen in 2011. This strain can be used in antimicrobial resistance research and drug development. It is resistant to vancomycin and the presence of the vanB gene was confirmed by PCR.

Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

### **Handling Procedures**

- 1. Open vial.
- 2. Using a single tube of #44 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.
- 5. Incubate the tubes and plate at 37°C for 24 hours.

#### Notes

PCR confirms presence of vanB gene conferring vancomycin resistance. Additional information on this culture is available on the ATCC $^{\circ}$  web site at www.atcc.org.
