## Growth Conditions

ATCC Medium 2: Marine agar 2216 or marine broth 2216

**Temperature:** 26°C**Atmosphere:** Aerobic

## Handling Procedures

1. Open vial.
2. Using a single tube of #2 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #2 agar slant and/or plate.

5. Incubate the tubes and plate at 26°C for 24 to 48 hours.

## Notes

Colonies on #2 agar are pinpoint, yellow, circular, entire, and smooth after 48 hours of incubation. Colonies become more yellow with age.
