



# *Escherichia coli* (Migula) Castellani and Chalmers

## Description

*Escherichia coli* strain NDM-1 is a whole-genome sequenced drug-resistant bacterium that was isolated in Pakistan. This strain is resistant to ertapenem and imipenem and was confirmed by PCR to contain the *bla*<sub>NDM</sub> gene. The bacterial culture can be used for antimicrobial resistance research, drug development, infectious disease research, and as a quality control strain for chromID Carba medium.

## Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0

- mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
  4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.
  5. Incubate the tubes and plate at 37°C for 24 hours.
