Thermodesulfobacterium geofontis strain OPF15 is a thermophilic type strain that was isolated in 2009 from an obsidian pool at Yellowstone National Park. This strain is propagated in OPF15 medium at 80°C.

Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

1. Open thawed vial according to enclosed instructions or visit www.atcc.org for instructions.

- 2. Under anaerobic conditions, aseptically transfer the entire contents to a 5-6 mL tube of #2879 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes. Best practice dictates the use of pre-reduced media.
- 3. Incubate in an anaerobic atmosphere at 80°C for 7 days. Incubate one agar plate aerobically at 37°C to check for contamination.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by the use of an anaerobic gas chamber or placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in an anaerobic chamber
- Loose screw caps on test tubes in an activated anaerobic gas pack jar
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained

Notes

Cells are non-motile Gram negative rods. For best growth, 20 mM formate should be added to the #2879 broth.

Always use freshly prepared pre-reduced media or pre-reduced media that has been previously prepared but stored under anaerobic conditions.
