Burkholderia multivorans strain LMG 13010 is a whole-genome sequenced bacterial type strain that was isolated from a cystic fibrosis patient in Belgium. The strain is recommended as a test microorganism for USP <60> Microbiological Examination of Nonsterile Products: Tests for *Burkholderia cepacia* Complex.

Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0

mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.

- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.
- 5. Incubate the tubes and plate at 30°C for 24-48 hours.
