Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Withdraw 0.5 mL of #260 broth from a single test tube (5 to 6 mL) and rehydrate the entire vial contents.
- 3. Aseptically transfer this aliquot back into the broth tube. Additional tubes may be inoculated with 0.5 mL each from the suspension. A slant and plates of #260 may also be inoculated with 0.2 mL.
- 4. Incubate at 37°C under an atmosphere of 5% CO₂.

Notes

In 1 week, growth is evident by turbidity and colonies on the agar surfaces. Colonies on #260 agar are tiny, α -hemolytic, grey, entire, convex, and circular.
