- Aseptically transfer the entire contents to a 5-6 mL tube of #1914 broth.
 Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes.
- 3. Use several drops of the primary broth tube to inoculate a #260 plate.
- 4. Incubate at 37°C under microaerophilic conditions for 3-5 days. Use an anaerobe jar with an active catalyst and a microaerophilic gas generator pack or other acceptable method. All tubes should be incubated with caps loosened.

Notes

Cells in broth are only visible under phase microscopy.

Sigma BSK-H can be used for growth as an alternative to ATCC Medium #1914 BSK

medium. Organism does not grow on agar
