*Escherichia coli* strain CFT073-WAM4505 is a UroPathogenic *E. coli* (UPEC) that was isolated from the blood of a patient with pyelonephritis. This strain contains wild type *rpoS* allele.

## Handling Procedures

1. Open vial.
2. Rehydrate the entire pellet with approximately 0.5 mL of #3 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #3 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these

- secondary tubes.
3. Use several drops of the primary broth tube to inoculate a #3 plate and/or #3 agar slant.
  4. Incubate at 37°C for 24 hours.

## Notes

Colonies on #3 agar are circular, entire, low convex, translucent and glistening. This is the true wild type CFT073 strain from the original patient isolate. Depositor determined this strain is positive for the *rpoS* allele with Sanger sequencing and Western blot.
