For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

- 1. Under anaerobic conditions, allow the frozen vial to thaw at room temperature.
- Using a 1.0 mL syringe tipped with 22-gauge needle, withdraw the entire cell suspension from the vial and transfer it to a broth tube and incubate at 30°C.
 Plate 0.1 mL of the inoculated culture onto a non-selective medium and incubate aerobically at 30°C.

3. Growth should be evident within 5 to 7 days in broth. Growth may take longer on solid medium. No growth should be evident on aerobic medium.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following

- Use of an anaerobic gas chamber, or
- Placement of test tubes under a gassing cannula system hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber,
- Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

Notes

Always use freshly prepared pre-reduced media or pre-reduced media that has been previously prepared but stored under anaerobic conditions.

Cells are thin rods that exhibit Gram-negative staining.
