- 1. Open vial according to enclosed instructions or visit www.atcc.org for instructions.
- 2. Rehydrate the entire pellet with approximately 0.5 mL of #18 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #18 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
- Use several drops of the primary broth tube to inoculate a #18 plate and/or #18 agar slant.
- 4. Incubate at 37°C for 24 hours.

Notes

This strain was confirmed by PCR to not carry the *stx*1, *stx*2, *eae*, *LT*, *STa*, *STb*, *cnf*1, and *cnf*2 genes (*stx*1-, *stx*2-, *eae*-). Additional information on this culture is available on the ATCC[®] web site at www.atcc.org.
