## Handling Procedures

1. Open vial according to enclosed instructions or visit [www.atcc.org](http://www.atcc.org) for instructions.
2. Rehydrate the entire pellet with approximately 0.5 mL of #18 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #18 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to

- these secondary tubes.
3. Use several drops of the primary broth tube to inoculate a #260 plate and/or #260 agar slant.
  4. Incubate at 37°C for 24-48 hours.

## Notes

Colonies on #260 agar may appear entire, smooth, glistening, low convex, and  $\beta$ -hemolytic.
