Handling Procedures

1. Open vial according to enclosed instructions.

2. Under anaerobic conditions, withdraw 0.5 ml of recommended broth from a single tube (5 to 6 ml) and rehydrate the entire vial contents.

3. Aseptically transfer this aliquot back into the broth. Additional tubes may be inoculated with 0.5 ml each from the suspension. A slant can be inoculated with 0.3 ml. Inoculate several blood agar plates to check for colonial morphology and purity.

4. Incubate tubes and one blood plate under anaerobic conditions at 37°C. Incubate the second plate aerobically as a contamination check.

5. Within 24 to 48 hours, colonies on #260 are flat to slightly peaked, gray and undulate. No growth should occur on the blood agar plate incubated aerobically.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

 \cdot Use of an anaerobic gas chamber, or

· Placement of test tubes under a gassing cannula system

hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

· Loose screw-caps on test tubes in anaerobic chamber,

 \cdot Loose screw-caps on test tubes in an activated anaerobic

gas pack jar, or

 \cdot Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

Notes

Always use freshly prepared pre-reduced media or pre-reduced media that has been previously prepared but stored under anaerobic conditions. Resazurin in the media is a color indicator for anaerobic conditions. Observance of pink color in medium before use or during incubation shows anaerobic conditions have not been met and oxidation has occurred. Medium should be discarded.
