Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

### Handling Procedures

- 1. Open thawed vial according to enclosed instructions or visit www.atcc.org for instructions.
- 2. Aseptically transfer the entire contents to a 5-6 mL tube of #1099 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
- 3. Use several drops of the primary broth tube to inoculate a #1099 plate and/or #1099 agar slant.

4. Incubate at 30°C for 48-72 hours.

#### Notes

The depositor states that this strain is oxidase negative, Gram-negative, and does not have pigmentation.

Please note that the deposior does not speak of 5%  $CO_2$ , though usually Legionella grows in 5%  $CO_2$ .
