## **Description**

*Bordetella pertussis* strain H375 was isolated in 2010 from the nasopharyngeal swab of an infant in California that had a fatal case of pertussis. The depositor states that this strain doesn't produce pertactin and that there is a deletion mutation at nucleotides 26-109. This product has applications in respiratory disease research and vaccine development.

## Handling Procedures

1. Open thawed vial according to enclosed instructions or visit [www.atcc.org](http://www.atcc.org) for instructions.
  2. Aseptically transfer the entire contents to a 5-6 mL tube of #35 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes.
  3. Use several drops of the primary broth tube to inoculate a #35 plate and/or #35 agar slant.
  4. Incubate at 37°C for 72 hours in an atmosphere of 5% CO<sub>2</sub>.
