Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submerged in liquid nitrogen.

2. Aseptically transfer the entire contents to a 5-6 mL tube of #35 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes.
3. Use several drops of the primary broth tube to inoculate a #35 plate and/or

4. Incubate at 37°C for 72 hours in an atmosphere of 5% CO<sub>2</sub>.
