1. Open thawed vial according to enclosed instructions or visit www.atcc.org for instructions.
2. Aseptically transfer the entire contents to a 5-6 mL tube of #35 broth.
Additional test tubes can be inoculated by transferring 0.5 mL of the primary

- broth tube to these secondary broth tubes.
3. Use several drops of the primary broth tube to inoculate a #35 plate and/or #35 agar slant.
 4. Incubate at 37°C for 72 hours in an atmosphere of 5% CO₂.
