Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

ATCC Medium 2063: *Desulfuromonas* medium

Temperature: 22°C

Atmosphere: 80% N₂, 20% CO₂

Handling Procedures

1. Open thawed vial according to enclosed instructions or visit www.atcc.org for instructions.
2. Under anaerobic conditions aseptically transfer the entire contents to a 5-6 mL tube of #2063 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes. Best practice dictates the use of pre-reduced media.

3. Use several drops of the primary broth tube to inoculate a Brucella blood plate.
4. Incubate in an anaerobic atmosphere at 22°C for 5-9 days. Incubate one agar plate aerobically at 37°C to check for contamination.

ANAEROBIC CONDITIONS:

- Anaerobic conditions for transfer may be obtained by the use of an anaerobic gas chamber or placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in an anaerobic chamber
- Loose screw caps on test tubes in an activated anaerobic gas pack jar
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained

Notes

The depositor states that strain ICBM is a Gram negative, nonmotile rod. It is reddish and contains c-type cytochromes.

Always use freshly prepared pre-reduced media or pre-reduced media that has been previously prepared but stored under anaerobic conditions.

Observed better growth using the depositor's medium formula.
