Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

1. Open thawed vial according to enclosed instructions or visit www.atcc.org for instructions.
2. Under anaerobic conditions aseptically transfer the entire contents to a 5-6 mL tube of #416 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes. Best practice

dictates the use of pre-reduced media.

3. Use several drops of the primary broth tube to inoculate a #416 plate and/or #416 agar slant.
4. Incubate in an anaerobic atmosphere at 37°C for 24 hours. Incubate one agar plate aerobically at 37°C to check for contamination.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by the use of an anaerobic gas chamber or placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in an anaerobic chamber
- Loose screw caps on test tubes in an activated anaerobic gas pack jar
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained

Notes

A second colony type may form after extended incubation in an anaerobic atmosphere.

A 5% CO₂ atmosphere can also be used to support the growth of this item; however, the growth time may take up to 48 hours, particularly when grown on agar.
