Handling Procedures

- 1. Open thawed vial.
- 2. Under anaerobic conditions aseptically transfer the entire contents to a 5-6 mL tube of #246 broth. Additional test tubes can be inoculated by transferring 0.5

mL of the primary broth tube to these secondary broth tubes. Best practice dictates the use of pre-reduced media.

- 3. Use several drops of the primary broth tube to inoculate a #246 plate and/or #246 agar slant.
- To obtain a biphasic culture, add several drops of the primary broth tube to a #246 agar slant overlaid with 1.0mL - 5.0mL #246 broth (adjust broth volume depending on the length of the slant).
- 5. Incubate in an anaerobic atmosphere at 37°C for 3-5 days. Incubate one agar plate aerobically at 37°C to check for contamination.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by the use of an anaerobic gas chamber or placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in an anaerobic chamber
- $_{\circ}\,$ Loose screw caps on test tubes in an activated anaerobic gas pack jar
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained

Notes
