



Akkermansia muciniphila **Derrien et al.**

Description

Akkermansia muciniphila strain m1-15 is a bacterial strain that was isolated from the cecal contents of a thirteen-lined ground squirrel (*Ictidomys tridecemlineatus*). This strain has mucin-dependent growth.

For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Growth Conditions

Medium:

ATCC Medium 0246: Fresh Beef Heart Infusion Broth with 0.2% Hemoglobin, 0.5% Mucin and 20% HI Turkey Serum

Temperature: 37°C

Atmosphere: Anaerobic

Handling Procedures

1. Open thawed vial.
2. Under anaerobic conditions aseptically transfer the entire contents to a 5-6 mL tube of #246 broth. Additional test tubes can be inoculated by transferring 0.5

mL of the primary broth tube to these secondary broth tubes. Best practice dictates the use of pre-reduced media.

3. Use several drops of the primary broth tube to inoculate a #246 plate and/or #246 agar slant.
4. To obtain a biphasic culture, add several drops of the primary broth tube to a #246 agar slant overlaid with 1.0mL - 5.0mL #246 broth (adjust broth volume depending on the length of the slant).
5. Incubate in an anaerobic atmosphere at 37°C for 3-5 days. Incubate one agar plate aerobically at 37°C to check for contamination.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by the use of an anaerobic gas chamber or placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in an anaerobic chamber
- Loose screw caps on test tubes in an activated anaerobic gas pack jar
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained

Notes

Growth on agar is poor; growth is preferred on biphasic slants.
